## Rules of Conduct for Senior Recreation Center Public Hours and Programs

The Urbandale Senior Recreation Center (SRC) enforces the following rules of conduct to ensure the rights and safety of its patrons and staff and to protect its materials, equipment, building, and grounds.

Patrons using the Senior Recreation Center are required to:

- Complete a membership form and update information as needed.
- Have a physician's release completed annually in order to participate in fitness programs.
- Sign in on the check-in computers each visit.
- Adhere to technology use policies when using SRC equipment.

Patrons visiting the Senior Recreation Center property may not:

- Engage in any behavior or activity that endangers the health or safety of others.
- Participate in illegal activities.
- Engage in lewd or inappropriate behavior.
- Interfere with another individual's use of the SRC or with SRC staff's performance of duties.
- Misuse, damage, or steal SRC property or the property of others.
- Use tobacco products or electronic cigarettes.
- Possess, consume, or be under the influence of an alcohol (except during approved programs/events) or illegal substances.
- Consume food or uncovered beverages in non-designated areas of the building.
- Use unauthorized entrances and exits or enter nonpublic areas.
- Bring animals into the building, except service animals or those involved in SRC program.
- Conduct surveys, petition, solicit, campaign, or engage in commercial activities, except for authorized SRC purposes.
- Interview, photograph, or audio/video record customers or staff unless authorized by SRC staff.
- Use the building without shoes or appropriate attire.

Failure to comply with Urbandale Senior Recreation Center policies may result in the suspension of privileges. Suspension length will be determined on a case-by-case basis. Suspensions may be appealed to the Parks and Recreation Director.
